14. Truck Tractor- A motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load other than a part of the weight of the vehicle and load so drawn.
15. Vehicle- Every device in, upon or by which any person or property is or may be transported or drawn upon a highway, except devices used exclusively upon rails or tracks. The term does not include a self-propelled wheel chair or an electrical mobility device operated by and designed for the exclusive use of a person with a mobility-related disability.

ARTICLE 2

Stop intersections and Stop Signs

§240-2. Stop Intersections Established

The stop intersections listed in Article 2 Subsection 240-3 are established as stop intersections, and official stop signs shall be erected in such a position as to face traffic approaching the second-named highway (the intersecting or through the highway) on the first-named highway (the stop highway) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or stop highway, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Pennsylvania Motor Vehicle Code, and shall not proceed into or across the second-named or intersecting or through highway until he has followed all applicable requirements of that section of the law.

§240-4. Placement of Signs.

The Borough Council shall direct the placement of signs at the designated stop intersections as provided in this ordinance.

§240-5. Violations and penalties.

Any person who shall violate this Article; shall upon conviction thereof before the District Magistrate will be sentenced to pay a fine of twenty five (\$25) Dollars plus costs of proceedings.

ARTICLE 3 One Way Streets

§240-6. One Way Streets

- A. South Water Street- Between East Erie Street and West School Drive
- B. Bunday Street- Between South Water Street an Rhodemeyer Street
- C. Rhodemeyer Street- Between Bunday Street and East Erie Street

D. Wallace Avenue- Between Penn Street and West Erie Street.

§240-7. Placement of Signs.

The Borough Council shall direct the placement of signs on the designated streets as provided in this ordinance.

§240-8. Violations and penalties.

Any person, firm or corporation who shall violate this Article; shall upon conviction thereof before the District Magistrate will be sentenced to pay a fine of twenty five (\$25) Dollars plus costs of proceedings

ARTICLE 4
Two Hour Parking

§240-9. Two Hour Parking Areas (Between the hours of 9 a.m. to 5 p.m.)

- A. West Erie Street South Side- Between Merry Drive and East Erie Street
- B. West Erie Street North Side- Between East Erie Street and Penn Street.
- C. South Pymatuning Street West Side- Between West Erie Street and Phoenix Alley
- D. South Mercer Street- Between West Erie Street and Phoenix Alley
- E. North Mercer Street West Side- Between West Erie Street and Mill Street
- F. North Pymatuning Street- Between West Erie Street and Mill Street
- G. West Erie Street Parking Lot- Between West Erie Street and Mill Street

§240-10. Vehicles to be parked within marked spaces

- A. Wherever a space shall be marked off on any street for the parking of an individual vehicle, every vehicle there parked shall be parked within the lines bounding such space.

240-11. Violations and Penalties

Ten (\$10) Dollar fine due in 48 hours

Twenty-five (\$25) Dollar fine if paid after 48 hours and before ten days

Citation issued after 10 days and a fine of fifty (\$50) Dollars plus costs of proceedings.

§240-12. Prohibited Parking

§240-14. Prohibited Parking from November 1st to May 1st

- A. All vehicles are prohibited from parking in the described parking areas anytime between the hours of 3 AM to 6 AM from November 1st to May 1st each year.

1. Two Hour Parking Areas

- i. West Erie Street South Side- Between Merry Drive and East Erie Street
- ii. West Erie Street North Side- Between East Erie Street and Penn Street.
- iii. South Pymatuning Street West Side- Between West Erie Street and Phoenix Alley
- iv. South Mercer Street- Between West Erie Street and Phoenix Alley
- v. North Mercer Street West Side- Between West Erie Street and Mill Street
- vi. North Pymatuning Street- Between West Erie Street and Mill Street
- vii. West Erie Street Parking Lot- Between West Erie Street and Mill Street

2. Wallace Avenue Parking Lot (beside Fire Department)

3. North Mercer Street Parking Lot (between Mill Street and Conneaut Street)

§240-15. Parking Same Direction as Traffic Flow

A. All parking on streets in Linesville Borough must be parked in the same direction as traffic flows. Parking facing oncoming traffic is prohibited.

1. Traffic flow north bound- vehicles parked to face north.
2. Traffic flow south bound- vehicles parked to face south.
3. Traffic flow east bound- vehicles parked to face east.
4. Traffic flow west bound- vehicles parked to face west.

§240-16. Violations and Penalties

Ten (\$10) Dollar fine due in 48 hours

Twenty-five (\$25) Dollar fine if paid after 48 hours and before ten days

Citation issued after 10 days and a fine of fifty (\$50) Dollars plus costs of proceedings.

Fines to be paid at the Police Department

ARTICLE 6
Handicap Parking

§240-17. Handicap Parking Regulations

1. No person other than a person to whom the Pennsylvania department of transportation or any other duly authorized governmental entity has issued a disabled veteran or handicapped registration plate or parking placard shall park or permit the parking of any vehicle in any handicapped parking space.
2. No otherwise qualified user of any handicapped parking space shall park or permit the parking of any vehicle in any such place unless that vehicle is clearly marked with the special disabled veteran or handicapped registration plate or parking placard issued by the Pennsylvania department of transportation or other duly authorized governmental entity. Absence of the clear and prominent display of a currently valid Pennsylvania department of transportation disabled veteran or handicapped registration plate or parking placard upon any vehicle parked in any handicapped parking space shall be conclusive evidence of a violation of this article.

§240-18. Placement of Signs.

The Borough Council shall direct the placement of handicap parking signs at whatever parking space Council shall deem to be handicap parking.

§240-19. Violations and Penalties.

Fifty (\$50) Dollar fine due within 10 days.

Citation issued after 10 days and a fine of not less than fifty (\$50) Dollars nor more than two hundred (\$200) dollars plus cost of proceedings.

ARTICLE 7 Speed Limits

§240-20. The speed limit on all Borough maintained streets shall be 25 Miles per Hour. All state maintained highways will be posted according to state regulations.

Article 8 Tractor Trailer Traffic on Borough Streets

§240-21. Borough Streets prohibiting Tractor Trailer Traffic.

A. North Pymatuning Street- North Bound.

1. Tractor Trailers traveling on West Erie Street are prohibited from turning onto North Pymatuning Street.
2. Tractor Trailers coming from the Linesville Business Park are permitted to travel Southbound on North Pymatuning Street to turn east onto West Erie Street

§240-22. Violations and Penalties

Any person, firm or corporation who shall violate this Article; shall upon conviction thereof before the District Magistrate will be sentenced to pay a fine of fifty (\$50) Dollars plus costs of proceedings.

ARTICLE 9 Noise from Vehicles

§240-23. Noise from Vehicles

It shall be unlawful for a person, firm or corporation being the owner or person in possession of a motor vehicle on public roadway with a device, to cause or permit any noise emanating from a motor vehicle which is a plainly audible at a distance of fifty (50') feet or greater from the motor vehicle. The lawful use of a motor vehicle horn shall not be a violation of his section.

§240-24. Violations and Penalties

Any person, firm or corporation who shall violate this Article; shall upon conviction thereof before the District Magistrate will be sentenced to pay a fine of fifty (\$50) Dollars plus costs of proceedings.


ARTICLE 10

Authority


§240.26. The Linesville Borough Police Department is authorized to enforce the provisions of Chapter 240.

**AN ORDINANCE AMENDING CHAPTER 240 OF THE CODE OF LINESVILLE
REGARDING TRAFFIC AND PARKING**

WHEREAS, the Borough of Linesville has established Traffic and Parking Regulations pursuant to Chapter 240 of the Code of Linesville Borough; and

WHEREAS, Council for the Borough of Linesville desires to amend Section 240-13 entitled "Prohibited on Street Parking"; and

WHEREAS, Council for the Borough of Linesville has determined it to be in the best interest of the welfare of the Borough to eliminate the prohibition for on street parking with respect to South Pymatuning Street as provided in Section 240-13(G) of the Ordinance.

NOW, THEREFORE, be it ordained by Council for the Borough of Linesville, County of Crawford, Commonwealth of Pennsylvania, and it is hereby ORDAINED and ENACTED as follows:

Section 240-13 entitled "Prohibited on Street Parking" as contained in Chapter 240 entitled "Traffic and Parking" of the Code of Linesville Borough is hereby amended as follows:

Paragraph G which reads "South Pymatuning Street (Phoenix Alley to Franklin Street)- No Parking on West Side of Street shall be deleted in its entirety.

All other provisions of Chapter 240 shall remain in force and effect and shall not be effected by this Amendment.

This Amendment shall take effect immediately upon passage hereof.

**NOTICE OF INTENT TO ADOPT ORDINANCE
BY THE BOROUGH OF LINESVILLE**

NOTICE is given that the Borough of Linesville intends to consider the passing of a proposed Ordinance to be known as **"The Linesville Borough Traffic and Parking Ordinance, Chapter 240 Vehicles and Traffic of the Code of Linesville Borough"**. The proposed Ordinance will be added to and amend Part II, General Legislation, of the Code of Linesville Borough, Chapter 240, and establishes traffic and parking regulations in the Borough of Linesville. Included in the Ordinance are the establishment of stop intersections, one-way streets, parking regulations, prohibited parking areas, handicapped parking regulations, speed limits, tractor-trailer traffic regulations, noise from vehicle regulations, as well as the establishment of violations and penalties for the various regulations contained therein. Furthermore, the Ordinance provides that the Linesville Borough Police Department is authorized to enforce the provisions of Chapter 240. The Borough Council of the Borough of Linesville shall consider the passing of this Ordinance at its May 13, 2014 meeting at 7 p.m. at the Linesville Borough Building located at 103 West Erie Street, Linesville, Pennsylvania.
