

**RESOLUTION NO. 3-2023**

**A RESOLUTION OF THE BOROUGH COUNCIL OF LINESVILLE BOROUGH, CRAWFORD COUNTY, PENNSYLVANIA, ADOPTING THE CONNEAUT VALLEY BOROUGH'S MULTI-MUNICIPAL COMPREHENSIVE PLAN, DATED THIS 14<sup>th</sup> DAY OF MARCH 2023 AS THE COMPREHENSIVE PLAN FOR LINESVILLE BOROUGH.**

**WHEREAS**, the Conneaut Valley Boroughs Multi-Municipal Comprehensive Plan is the municipal comprehensive plan of Linesville Borough; and

**WHEREAS**, a copy of the comprehensive plan, which includes the text, maps, charts and other items comprising the plan document including its appendices which form the whole of the comprehensive plan was made available for public review at the Linesville Borough Town Hall at 103 West Erie Street, Linesville PA, 16424 and online is appended to this resolution; and

**WHEREAS**, the Conneaut Valley Boroughs Multi-Municipal Comprehensive Plan was sent to the Crawford County Planning Commission, the surrounding township(s) of Pine and Conneaut, and the Conneaut School District for their review and comments at least forty-five (45) days before the consideration of this resolution; and

**WHEREAS**, notice of a public meeting before the Borough's Planning Commission/Committee was lawfully provided to seek public input; and

**WHEREAS**, the Borough Council held a public hearing on December 13, 2022, per public notice, to hear and consider public comments, and that the comments received at the public hearing were duly noted; and


**WHEREAS**, the Borough Council has determined that the adoption of the comprehensive plan will benefit the health, safety, and welfare of the citizens of the borough; and

**NOW, THEREFORE, BE IT RESOLVED** that:

- 1) The Council of the Borough of Linesville by this resolution, adopts the Conneaut Valley Boroughs Multi-Municipal Comprehensive Plan as attached pursuant to Article III and Article XI of the Pennsylvania Municipalities Planning Code; and
- 2) This resolution, upon adoption and signature, shall be recorded on the adopted comprehensive plan.
- 3) The Council of the Borough of Linesville may pursue cooperative efforts with the other municipalities adopting this comprehensive plan per the Pennsylvania Municipalities Planning Code.




